SUBJECT: AFRC Undergraduate Flying Training (UFT) Selection Board 25-01 Results

*** OFFICIAL BOARD SELECTION DATE IS JANUARY 23, 2025 ***

1. The individuals listed in Attachment 1 were selected for Undergraduate Flying Training by AFRC UFT Selection Board 25-01 which convened in accordance with DAFI36-2137 on 23 Jan 25 at HQ AFRC. The approval authority for UFT exceptions to policy (ETP) is AFRC/CC (DAFI36-2137, Table 5.1), delegated to AFRC/A3/10 via memo "Delegations of AFRC/CC Authority," Nov 2022. Approved ETPs are annotated in Attachment 1. All selectees are approved to attend Officer Training School (OTS) as required, including those with ETPs, per AF/RED's delegation of OTS selection authority to AFRC/A3/10 (17 May 23).

- a. **Commanders**: Notify selectees within 7 days of receipt of this message. One week after this message is sent to commanders, it will be forwarded to AFRC Officer Accession Recruiters, Unit Hiring POCs, and 487 TRS for selectee notification and processing.
- b. **Recruiters/Unit Hiring POCs**: Notify selectees immediately upon receipt of this message and coordinate future gain/in-processing actions.
- c. 487 TRS: Upon receipt of this message, contact selectees for gain/in-processing.
- d. **Selectees:** The 487th Training Squadron will be in contact with you soon to facilitate your gain into the Air Force Reserve. Be prepared for delays in this process, depending upon the status of your flight physical and training availability. 2. AFRC convenes UFT Selection Boards quarterly in January, April, July and October. The next board will convene on or about 24 Apr 25, with an application deadline of 31 Mar 25.
